Dru Levasseur is the Deputy Program Officer of the National LGBT Bar Association, expanding the Bar's programmatic work, including Lavender Law 365, an LGBTQ+ inclusion coaching and consulting initiative perfect for law firms, law schools, and workplaces. As a leading figure in the LGBTQ+ equality movement for 25 years, 15 of which in the legal profession, Dru has extensive experience in law, advocacy, philanthropy, and community organizing. Previously, Dru was Senior Attorney and Transgender Rights Project Director for Lambda Legal, the oldest and largest national legal organization committed to achieving full recognition of the civil rights of LGBTQ+ people and people living with HIV. For a decade, Dru led Lambda Legal's transgender rights work through strategy development, impact litigation, policy advocacy, and public education. He served as counsel in landmark impact litigation cases and amicus briefs in federal courts, including the U.S. Supreme Court.
